There were individual suggestions which I have emailed parents about personally, but these are comments made by more than one parent:

- Parents commented positively on our special events, how welcoming we are, the successful transition across all year groups, our amazing team, being active in the community, Family Learning Time, our WW1 week and Forest Schools.
- There was a request for advice on internet safety. We will run our annual information session next term.
- There was a suggestion about advising the children on money and finance. We will continue to explore appropriate options for doing this.
- There were a number of comments about the local library. We are working alongside the Junior School and Ducklings to support the campaign against its closure.
- 2.2% of parents said we do not communicate well. We welcome your feedback on how we can communicate most effectively with parents.
- 2.9% of parents feel their child does not receive appropriate home learning. However, comments are evenly split between those that think there is too much/too difficult and not enough/too easy home learning. We will continue to try and find a balance that works!
